## **Agreement between User and whatsthemove.co**

Welcome to whatsthemove.co. The whatsthemove.co website (the "Site") is comprised of various web pages operated by What's the Move ("WtM"). whatsthemove.co is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms").
